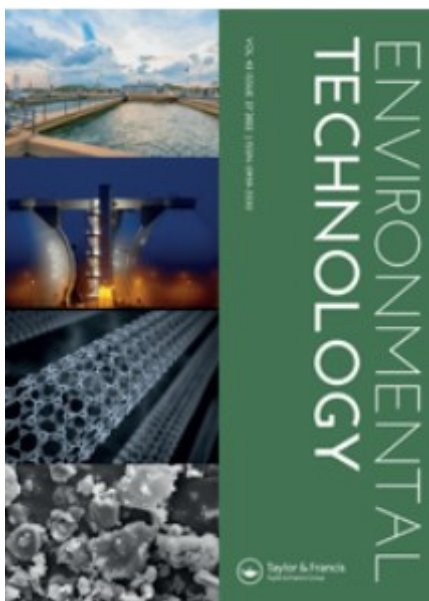
Aims & Scope

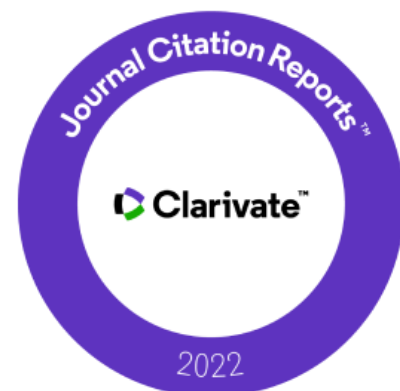
